### ARTICLE 1 - NAME

The Name of the corporation shall be. Boca Raton Consultants, THC.

## ARTICLE 2 - DURATION

This corporation shall exist in perpetuity.

### ARTICLE 3 - PURPOSE

General nature of the business and the object and purposes proposed to be transacted and carried on, are to do any and all of the things mentioned herein, as fully and to the same extent as natural personas might or cud, viz: Engage in any business or activity permitted under the laws of the United States and the State of Florida, including but not to the following:
