The undersigned, for the purpose of forming a for-profit corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation:

**ARTICLE ONE
NAME**

The name of the Corporation is Sonshine Builders, Inc.

**ARTICLE TWO
DURATION**

The term of existence of the Corporation is perpetual.

**ARTICLE THREE
PURPOSE**

The purpose for which the Corporation is formed is to engage in the construction of commercial and residential buildings and structures and may, in addition, engage in any and all lawful businesses for which corporations may be incorporated under the Florida General Corporation Act.

**ARTICLE FOUR
CAPITAL STOCK**

The aggregate number of shares which the Corporation has authority to issue is One Thousand (1,000), all of which shall be common shares with a par value of Ten Dollars (\$10.00) per share.

There shall be no Board of Directors.


**ARTICLE EIGHT

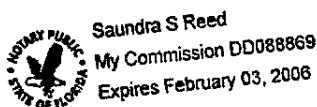


