

2. That the Corporation was administratively dissolved by the Florida Department of State on 1 October 2004.

6. No further ground or grounds exist for the administrative dissolution of the Corporation.

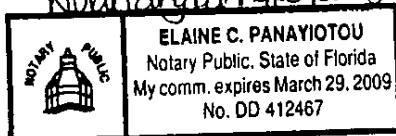
