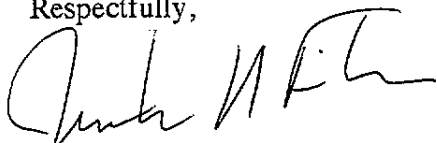

ARTICLE I

NAME

The name of the Corporation shall be SCHWARTZ MAINTENANCE CONSULTING, INC. and the address of this Corporation shall be 7461 S. W. AUTUMN LANE, HOBE SOUND, FL 33455.

ARTICLE II

DURATION

This Corporation shall have perpetual existence unless dissolved by administrative action.

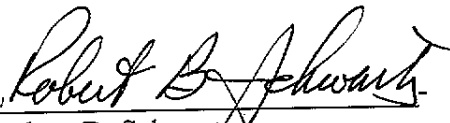
