

It has come to our attention that our corporation is in administrative dissolution. We wish to correct this situation immediately as we were unaware of this status.

Please find attached a printout of the information from your website showing our corporation's information. When we looked up this information, we noted that our address is incorrect and has been for some time. This was the previous home address of the owner of the company, Mr. Donato DiNoria, when United Materials was originally formed. This is probably the reason we did not receive notification about the requirement to file the annual report.

We had advised our accountants Thomas Wanderon & Associates of our address change at the time of the move and the opening of the company's offices on Trade Center Way in Naples. We believed this would result in the necessary changes on Federal and State forms.
