The undersigned, for the purpose of forming a Corporation under Chapter 621 of the Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of this Corporation (hereinafter referred to as "Corporation") is:

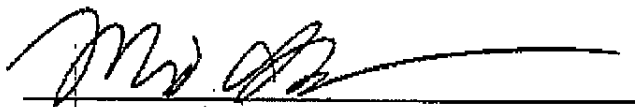
