OF  
ONE WAY COMMUNICATIONS, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**ARTICLE I - NAME**

The name of this corporation is ONE WAY COMMUNICATIONS, INC.

**ARTICLE II - DURATION**

This corporation shall exist perpetually commencing April 20, 2002.

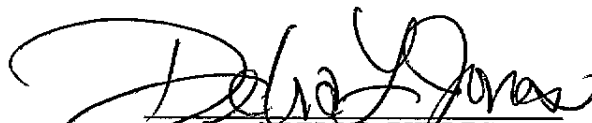

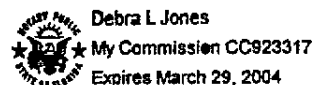
