THE UNDERSIGNED, ACTING AS THE INCORPORATOR OF A CORPORATION UNDER THE FLORIDA BUSINESS CORPORATION ACT, CHAPTER 607 AND/OR CHAPTER 621, FLORIDA STATUTES, ADOPT THE FOLLOWING ARTICLES OF INCORPORATION FOR SUCH CORPORATION.




