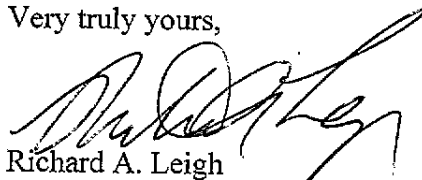

ARTICLES OF INCORPORATION
OF

BUSCK ENTERPRISES, INC.

ARTICLE I. NAME

The name of this corporation is BUSCK ENTERPRISES, INC.

ARTICLE II. PURPOSE

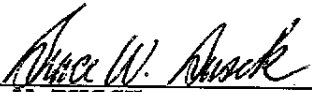

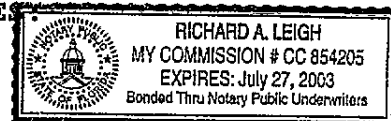

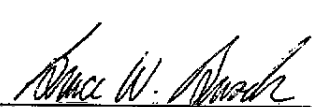
