ARTICLE I
CORPORATE NAME

The name of this corporation is **HOME ASSESSMENT GUIDE, INC.**

ARTICLE II
INITIAL PRINCIPAL PLACE OF BUSINESS

ARTICLE III
NATURE OF BUSINESS AND POWERS

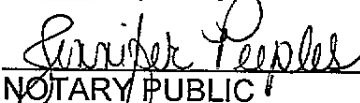
