ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of Reynolds Industries of Southwest Florida, Inc. under the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is:

ARTICLE III. PURPOSE

The maximum number of shares that the corporation is authorized to have outstanding at any time is 1,000 shares of common stock having no par value. 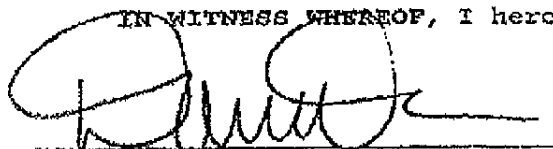

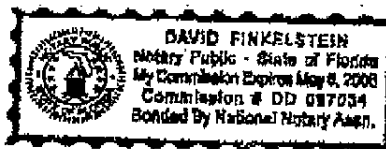
