### ARTICLE I NAME

The name of the corporation shall be: T. TIGER, INC.

The principal address is:

1730 Northeast 59th Court, Fort Lauderdale, Florida 33334.

### ARTICLE II PURPOSE

To engage in any activity or business permitted under the laws of the United States and the State of Florida.

### ARTICLE III CAPITAL STOCK

The corporation is authorized to issue 10,000 shares of common stock at \$.10 par value. The common stock of the corporation shall have the following characteristics:

- (a) At all meetings of the stockholders, the voting common stockholders shall be entitle to cast one (1) vote for each share of common stock owned. That a voting common stockholder is interested in a matter to be voted upon shall not disqualify him from voting thereon.
- (b) Except as otherwise provided by law, the entire voting power for the election of the directors and for all other purposes shall be vested exclusively in the holders of the outstanding voting common stock.

This corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Secretary of the State of Florida.

# ARTICLE V INITIAL REGISTERED OFFICE AND AGENT

The Board of Directors may, from time to time, change the street and post office address of the corporation as well as the location of its principal office.

This corporation shall have one (1) director initially. The number of directors may be increased from time to time in accordance with the By-Laws but shall never be less than one (1).
