The undersigned, for the purpose of forming a corporation under the Florida Professional Service Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of this corporation is M & M PAINTING & PRESSURE CLEANING, INC.

**ARTICLE II
PURPOSE**

This corporation is organized for the purpose of providing painting, pressure-cleaning services, renovation of building exteriors, renovation of building interiors and all other related activities permitted under the laws of the State of Florida and the United States of America.

SUB-CHAPTER S CORPORATION**


This corporation may elect to be treated as a Sub-Chapter S Corporation as defined by the Internal Revenue Code.
