ARTICLE ONE

The name of this corporation is JCO ENTERPRISES, INC. and the mailing address of the corporation shall be 4600 Summerlin Road, #C6, Fort Myers, FL 33919.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.

ARTICLE THREE

The duration of the corporation is perpetual.

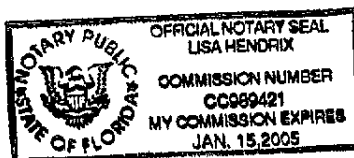

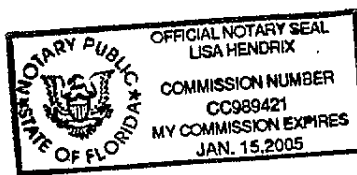

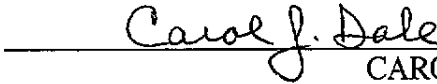
