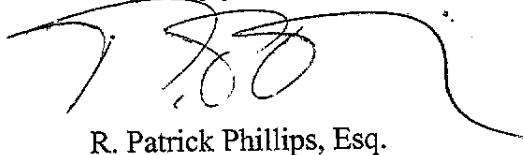

ARTICLE I - NAME OF CORPORATION

The name of this corporation is PERSONAL BEST SPEACH SERVICES, INC.

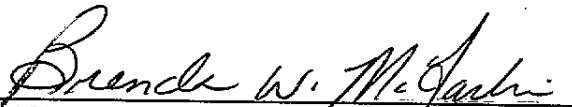

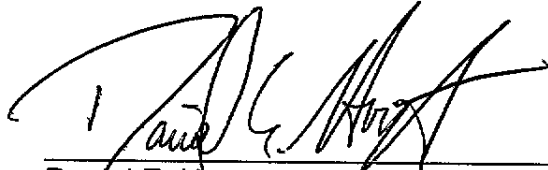
