The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of the corporation shall be: R. ISAACS COMPUTING ASSOCIATES OF FLORIDA, INC.
