## ARTICLES OF DISSOLUTION FOR DANCE OLYMPIA, INCORPORATED

On April 30, 2002 a corporation entitled Dance Olympia, Incorporated was officially established. The corporation was officially established in error. What my client wanted to do was to reinstate an older corporation with the same name which was administratively dissolved in 1991. Enclosed you will find the document entitled "Articles of Dissolution of Dance Olympia, Incorporated." Please dissolve this corporation which was filed on April 30, 2002. Paragraph 7 of the Articles of Dissolution explain the reason for this filing and further state that the corporation has no intention of revoking these particular Articles of Dissolution. It is important that this step take place first so that the name will again become available for the corporation which was originally formed in 1990. Once the Articles of Dissolution have been filed, the corporation dissolved and the name again becomes available, it will then be necessary to move to the second part of this mailing which is the reinstatement of the older corporation. ## CORPORATION REINSTATEMENT FOR DANCE OLYMPIA. INCORPORATED

To this end, enclosed you will find the form entitled "Corporation Reinstatement." As you can see, my client's desire was to reinstate Dance Olympia, Incorporated which was incorporated on April 2, 1990 and then later dissolved in 1991. Enclosed you will find Check No. 24380 payable to the Department of State in the amount of \$2,320.00. I obtained this amount using the following formula: \$600.00 + \$61.25 + \$1,650.00 (I multiplied  $11 \times $150.00$ ) + \$8.75 (for Certificate of Status) = \$2,320.00. Once the corporation has been reinstated, please return the Certificate of Status and any other receipts to this office.
