The undersigned does hereby subscribe to, acknowledge and file the following articles of incorporation for the purpose of creating a corporation under the laws of the State of Florida.

## ARTICLE I - NAME

The name of this corporation is:

## ARTICLE II - PURPOSE

\* This corporation is organized for the purpose of operating a law office under the laws of Florida.

## ARTICLE III - CAPITAL STOCK




