**ARTICLES OF INCORPORATION  
OF

**ARTICLE I - NAME:** The name of this corporation is WINTERROWD DESIGN GROUP, INC.

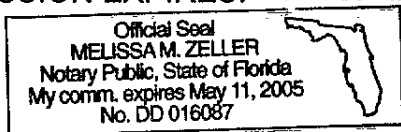
