ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND ADDRESS

The name of the Corporation shall be ENDEAVOR INVESTMENTS, INC., with its principal place of business at 5460 Northeast 11th Avenue, Ocala, Florida 34479.

ARTICLE VI - BOARD OF DIRECTORS

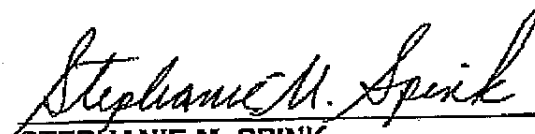

ARTICLE VIII - BY-LAWS

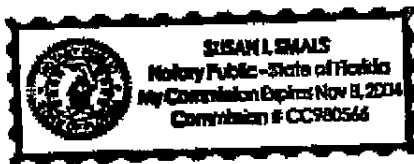
The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the Shareholders.
