The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the Laws of the State of Florida.

ARTICLE I

Name

The name of the corporation is: TEXTILES 1 X 1 U.S.A., INC.

ARTICLE II

Principal Office and Mailing Address

The street address of the initial principal office and mailing address of this corporation shall be: 335 Largo Cay Court, Suite 203, Ocoee, Florida 34761.

Nature of Business
