ARTICLE I - NAME

The name of this corporation is: EDGEWOOD AVENUE MAGIK, INC.

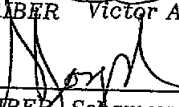

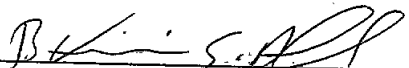

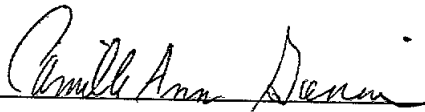
