THE UNDERSIGNED, FOR THE PURPOSE OF FORMING A CORPORATION TO UNDER THE FLORIDA GENERAL CORPORATION ACT, DOES HEREBY ADOPTOTHE FOLLOWING ARTICLES OF ENCORPORATION:

ARTICLE I
