PROFITS AND LOSSES IN ANY TRANSACTION OF TRANSACTIONS.



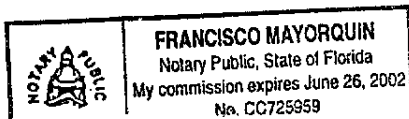
