Article I

NAME

The name of the corporation is **Service Guia** and the principal address shall be 1230 WEST 54 STREET # A-218 HIALEAH, FLORIDA 33012

Article li

DURATION

The Corporation shall exist perpetually. Corporate existence shall commence up in filing by The Department of State.

Article III
