ARTICLE I

The name of this corporation is A NATIVE WOOD WORKS, INC. Whose principal address is 5741 Dawson Street, Hollywood, Florida 33023

ARTICLE II

The general nature of the business to be transacted by this corporation is to engage in the manufacture of cabinets, a business permitted under the laws of the State of Florida.

ARTICLE III

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is ONE THOUSAND (1,000) shares of common stock having a par value of ONE DOLLAR (\$1.00) per share.




