

## ARTICLE X INDEMNIFICATION



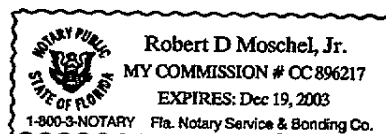
