The undersigned subscriber to these Articles of Incorporation, a natural person competent to do so, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation is: WebDat, Inc.

ARTICLE II

NATURE OF BUSINESS

The general character or nature of the business to be transacted by this Corporation is to engage in any and all lawful business, trades, occupations and professions, including the transaction of any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE III

CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any time is One Thousand (1000) shares of common stock, each share having the par value of One dollar (\$1.00).

Authorized capital stock may be paid for in cash, services or property, at a just value to be fixed by the Board of Directors of this Corporation at any regular or special meeting.

#### ARTICLE IV

##### INITIAL CAPITAL

The amount of capital with which this Corporation shall begin is not less than One Hundred (\$100.00) Dollars.

#### ARTICLE V

##### TERM OF EXISTENCE

This corporation shall have perpetual existence.

#### ARTICLE VI

##### ADDRESS AND RESIDENT AGENT

This initial street address of the principal office of this Corporation is 127 Patale Drive, Tallahassee, Florida 32317. The Board of Directors may from time to time designate such other address and place for the principal office of this Corporation as it may see fit.
