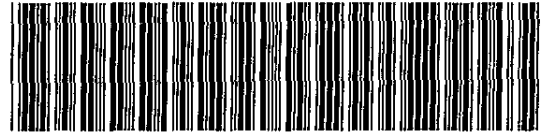

ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
MEDICAL HELP STAT, INC.

Pursuant to the provisions of Chapter 607, the Florida Business Corporation Act, and Chapter 621, the Professional Service Corporation and Limited Liability Company Act, of the Florida Statutes, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is MEDICAL HELP STAT, INC.

SECOND: The Corporation is re-incorporated under the provisions of Chapter 607, the Business Corporation Act, and Chapter 621, the Professional Service Corporation and Limited Liability Company Act, of the Florida Statutes.

THIRD: The following amendments of the Articles of Incorporation of the Corporation were adopted by the Stockholder and Director of the Corporation effective on October 20, 2003, in the manner prescribed by the Florida Statutes:

Amendment Number One. "The Articles of Incorporation of the Corporation are amended by deleting Article I of the Articles of Incorporation and substituting in lieu thereof the following new Article I:

"ARTICLE I

"The name of the Corporation is "MEDICAL HELP STAT, P. A."

Amendment Number Two. "The Articles of Incorporation of the Corporation are amended by deleting the first two paragraphs of Article III of the Articles of Incorporation and substituting in lieu thereof the following paragraphs:

"ARTICLE III

"The purpose for which the Corporation is organized, which shall continue to be the purpose of the Corporation until and if the same shall be amended pursuant to the provisions of the Business Corporation Act and the Professional Service Corporation and Limited Liability Company Act, and which shall include the authority of the Corporation to transact any lawful business for

which professional corporations may be incorporated under the Professional Service Corporation and Limited Liability Company Act and the Business Corporation Act, are as follows:

"To engage in medical consulting activities and to provide for medical, nursing, and physician services by persons duly licensed to render such medical services to the public."
