

ARTICLES OF INCORPORATION OF AMAZON PAINTING, INC.

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I Name

The name of this corporation is: Amazon Painting, Inc.

ARTICLE II Duration

The corporation shall be governed by bylaws adopted by the shareholders.


