The undersigned incorporator hereby executes these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

**ARTICLE I**

Name

The name of this corporation shall be: **TAMPA E N T SPECIALISTS, INC.**

**ARTICLE II**

Principal Office and Mailing Address

**ARTICLE III**

Purposes and Duration
