The Undersigned, acting as incorporator of a corporation and the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is South Lake Hospitalists, P.A.

ARTICLE II - NATURE OF BUSINESS
