ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation is Rockline Vac Systems North, Inc.

ARTICLE II - DURATION

EFFECTIVE DATE

4-15-02

The duration of the corporation shall be perpetual and shall commence upon the signing and acknowledging of these Articles.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one thousand (1000) shares of One-Dollar (\$1.00) par value common stock. All stock of the corporation shall be issued pursuant to a plan under Section 1244 of the Internal Revenue Code of 1954 as added by the Small Business Tax Revision Act of 1958.

The corporation shall indemnify any officers or directors, or any former officer or directors, to the full extent permitted by law.


ARTICLE XI - AMENDMENT
