The aggregate number of shares which the corporation shall have authority to issue is 1000, at -0- par value.

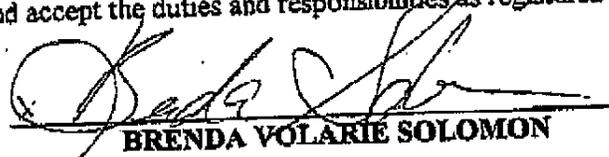
ARTICLE FIVE
