**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is POUND 4 POUND PROMOTIONS, INC., and the principal address and principal place of business is 4400 34TH STREET NORTH, UNIT H, ST. PETERSBURG, FLORIDA 33714.

ARTICLE II - REGISTERED OFFICE AND AGENT

ARTICLE VI - AMENDMENTS




