**ARTICLES OF INCORPORATION
OF
THE ARENA BOXING GYM, INC.**

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is THE ARENA BOXING GYM, INC., and the principal address and principal place of business is 4400 34TH STREET NORTH, UNIT H, ST. PETERSBURG, FLORIDA 33714.

ARTICLE II - REGISTERED OFFICE AND AGENT

ARTICLE VI - AMENDMENTS


