We, the undersigned, being natural persons of legal age, desirous of forming a corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be JNR Enterprises, Inc. No. 1

ARTICLE II OFFICE

The principal office of the corporation and its mailing address shall be 2904 South Orange Blossom Trail, Orlando, Florida 32805, in Orange County.

ARTICLE III STOCK

The maximum number of shares of stock of this corporation authorized to be outstanding at any one time is Five Hundred (500) shares having a par value of \$1.00 per share. The consideration to be paid for each share of stock shall be fixed by the Board of Directors of the corporation.
