The undersigned, being duly licensed to practice veterinary medicine in the State of Florida, desires to form a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Service Corporation Act, adopts the following Articles of Incorporation.

ARTICLE 1

Name

The name of this corporation is: _____

ARTICLE 2

Duration

This corporation shall have perpetual existence, commencing upon filing.

ARTICLE 3

Principal Office and Mailing Address

ARTICLE 4

Purpose

The purpose for which this corporation is organized shall be to engage in the practice of veterinary medicine within the State of Florida, and to take all actions that are necessary or proper in connection with that practice.

ARTICLE 5

The professional services of this corporation shall be rendered only through officers, employees, and agents who are duly licensed or otherwise legally authorized to practice veterinary medicine within the State of Florida. Professional Services shall be rendered in each case by the officer, employee, or agent designated solely by this corporation, acting through its duly elected officers. This provision shall not be applicable to the extent it is in conflict with the law or the professional rules of veterinary practice.

ARTICLE 6

Capital Stock

This corporation is authorized to issue ten thousand (10,000) shares of common stock, each with a par value of one cent (\$.01).

ARTICLE 7

Preemptive Rights

This corporation elects to have preemptive rights.

ARTICLE 8

Initial Registered Office and Agent

Indemnification


This corporation shall indemnify any officer or director, or any former officer or director, to the fullest extent permitted by law.
