ARTICLES OF INCORPORATION
OF
DIPLOMATIC K-9 DETECTION SERVICES, INC.

FIRST: The name of this corporation is DIPLOMATIC K-9 DETECTION SERVICES, INC., and its corporate mailing address is Post Office Box 1009, Lake Hamilton, Florida 33851-1009.

SECOND: The general nature of the business or businesses to be transacted by this Corporation, together with and in addition to those powers conferred by the laws of Florida and the United States of America and the principles of common law upon corporations organized under and by virtue of the laws of Florida, is to provide security services.

THIRD: The maximum number of shares of stock that this Corporation is authorized to have outstanding at one time is Ten Thousand (10,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

FOURTH: The amount of capital with which this Corporation will begin business is Five Hundred Dollars (\$500.00).




