ARTICLES OF INCORPORATION

OF

NATHAN R. MILLER CORP.

ARTICLE I: NAME

The name of this corporation is **NATHAN R. MILLER CORP.**, whose address **333 Sunset Avenue, Apartment, 702 Palm Beach, Florida 33480.**

ARTICLE II: DURATION

This corporation shall have perpetual existence.

ARTICLE III: PURPOSE


This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

is subject to this reservation.




