ARTICLES OF INCORPORATION

OF

ARTICLE I: NAME

The name of this corporation is NATHAN R. MILLER CORP., whose address 333 Sunset Avenue, Apartment, 702 Palm Beach, Florida 33480.

ARTICLE II: DURATION

This corporation shall have perpetual existence.
