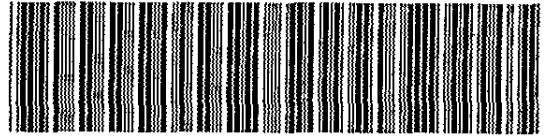

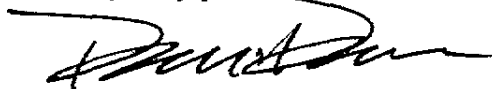

"ARTICLE I"

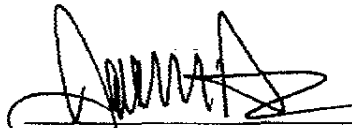
