The period of duration of this corporation is perpetual.


ARTICLE VIII. INDEMNIFICATION

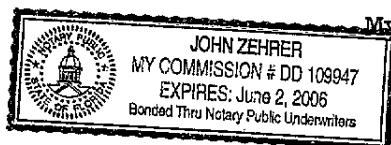



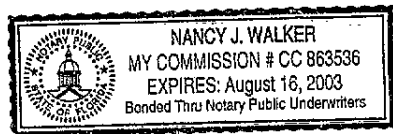
