## ARTICLES OF INCORPORATION

A-1 Best Lock + Door, Inc

ARTICLE I - NAME

The Name of the corporation shall be.

ARTICLE 2 - DURATION

This corporation shall exist in perpetuity.

ARTICLE 3 - PURPOSE
