ARTICLES OF INCORPORATION

ARTICLE I

The name of the corporation is JOHNNIE MILLER, INC.

ARTICLE II

The principal office and mailing address of the corporation is 123 Lincoln Blvd., Orlando, Florida 32810.

The number of shares the corporation is authorized to issue is 10,000 common, \$1.00 par value, consisting of one class only.


