# ARTICLES OF INCORPORATION OF THE "ALL ABOUT YOU" SALON OF KEY WEST, INQ2 APR 30 PM 1: 16

The undersigned, subscribers to these articles of incorporation, natural persons competent to STATE contract, hereby presents these article for the formation of a corporation under the provisions of Chapter 607, Florida Statutes, also known as The Florida Business Corporation Act, and other laws of the State of Florida.

#### ARTICLE I NAME

The name of this Corporation is THE "ALL ABOUT YOU" SALON OF KEY WEST, INC.

## ARTICLE II NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:

To engage in every phase and aspect of the business of rendering aesthetic and cosmetic personal care services through officers, employees, and agents who are duly licensed under the laws of the State of Florida to render those services.

To invest the funds of this corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and to own real and personal property necessary for the rendering of aesthetic and cosmetic personal care services.

To do all and everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objects or the furtherance of any of the purposes enumerated in these Article of Incorporation, and in general, either alone or in association with other corporations, firms or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment of the purposes or objects of this Corporation.

The foregoing paragraphs shall be construed as enumerating both objects and purposes of this Corporation; and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of this Corporation otherwise permitted by law.

#### ARTICLE III CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is 1,000 shares of common stock, having a par value of \$1.00 per share.

#### ARTICLE IV INITIAL CAPITAL

The amount of capital with which this Corporation shall commence business shall be not less than Five Hundred Dollars (\$500.00).

# ARTICLE V TERM OF EXISTENCE

This Corporation shall commence its existence upon the filling of these Article of Incorporation and shall continue perpetually thereafter, unless sooner dissolved according to law.

#### ARTICLE VII DIRECTORS

This Corporation shall have two (2) Directors initially. The number of Directors may be increased or diminished from time to time by Bylaws adopted by the Shareholders, but shall never be less than one (1).

## ARTICLE X VOTING TRUSTS

No Shareholder of this Corporation shall enter into a voting trust agreement or any other type of agreement vesting in another person the authority to exercise the voting power of any or all of his shares.

## ARTICLE XI CUMULATIVE VOTING FOR DIRECTORS

At all elections of Directors of this Corporation, each Shareholder shall be entitled to as many votes as shall equal the number of votes which (except for these provisions as to cumulative voting) he would be entitled to cast for election of Directors with respect to his shares of stock multiplied by the number of Directors to be elected, and he may cast all such votes for a single Director, or may distribute them among the number to be voted for, or any two or more of them as he may see fit.

## ARTICLE XII CONTRACTS

No contract of other transaction between this Corporation and any other corporation shall be affected by the fact that any Director of this Corporation is interested in, or is a director or officer of such other corporation, or may be interested, any contract or transaction of this Corporation or in which this Corporation is interested: and no contract, or other transaction of this Corporation with any person firm, or corporation shall be affected by the fact that any director of this Corporation is a party in any way connected with such person, firm or corporation, and every person who may become a Director of this Corporation is hereby relieved from any liability the

might otherwise exist from contracting with this corporation for the benefit of himself or any firm association, or corporation in which he may be in any way interested.

This Corporation shall have the power, at its option, to purchase and acquire any and all of its shares owned and held by any such shareholder as should desire to sell, transfer, or otherwise dispose of these shares, in accordance with the Bylaws adopted by the Shareholders of this Corporation setting forth the terms and conditions of such purchases; provided, however, the capital of this Corporation is not impaired.

This Corporation shall have the power, at its option, to purchase and acquire the shares owned and held by any shareholder who dies, in accordance with the Bylaws adopted by the Shareholders of this Corporation setting forth the terms and conditions of such purchase; provided, however, the capital of this Corporation is not impaired.

This Corporation shall have the power to enter into, for the benefit of its employees, one or more of the following:

- 1. a pension plan;
- 2. a profit sharing plan, if such plan is not otherwise prohibited by the Code of Ethics of the Profession;
- 3. a stock bonus plan;
- 4. a thrift and savings plan;
- 5. a restricted stock option plan; or
- 6. other retirement or incentive compensation plans.

## ARTICLE XIII AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the Shareholders and approved at a Shareholders' meeting by a majority of the stock entitled to vote there unless all of the Directors and all of the Shareholders sign a written statement manifesting their intention that a certain amendment of these Article of Incorporation be made. All rights of Shareholders are subject to this reservation.

## ARTICLE XIV PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this Corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price which it is offered to others.
