THE UNDERSIGNED, acting as sole incorporator of NEW CANTON AT ORLANDO, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME**

**ARTICLE II


