

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida. SECRETARY OF STATE
TALLAHASSEE FLORIDA

ARTICLE I: NAME

The name of the corporation shall be PANIX CORPORATION. The address of the principal office of this corporation shall be 5705 Hansel Avenue, Orlando, FL 32809, and the mailing address of the corporation shall be the same.

ARTICLE II: NATURE OF BUSINESS AND PURPOSE




