# ARTICLES OF INCORPORATION OF BACK IN TOUCH DAY SPA, INC.

#### ARTICLE I-Name

The name of this corporation is BACK IN TOUCH DAY SPA, Inc.

#### ARTICLE II- Principal Office

The address of the principal office and mailing address is 2533 US 27 South, Sebring, Florida 33870.

#### ARTICLE III-Duration

This corporation shall have perpetual existence.

#### **ARTICLE IV-Purpose**

This corporation is organized for the purpose of transacting any or all lawful business.
