The undersigned, an individual licensed to practice law in the State of Florida and acting as incorporator, hereby adopts these Articles of Incorporation for the purpose of organizing a Professional Corporation pursuant to the provisions of the Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes (the "Act") and other applicable laws of the State of Florida.

#### ARTICLE I-NAME
